# **Privacy Policy**

USAF FAC 3.0 ("us", "we", or "our") operates the USAF FAC 3.0 mobile application (hereinafter referred to as the "Service").

This page informs you of our policies regarding the collection, use and disclosure of personal data when you use our Service and the choices you have associated with that data.

We use your data to provide and improve the Service. By using the Service, you agree to the collection and use of information in accordance with this policy.

## **Definitions**

#### Service

Service is the USAF FAC 3.0 mobile application operated by USAF FAC 3.0

#### Personal Data

Personal Data means data about a living individual who can be identified from those data (or from those and other information either in our possession or likely to come into our possession).

#### Usage Data

Usage Data is data collected automatically either generated by the use of the Service or from the Service infrastructure itself (for example, the duration of a page visit).

#### Cookies

Cookies are small files stored on your device (computer or mobile device).

## **Types of Data Collected**

#### **Personal Data**

USAF FAC 3.0 will take all the steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy and no transfer of your Personal Data will take place to an organisation or a country unless there are adequate

controls in place including the security of your data and other personal information.

## **Disclosure of Data**

#### **Business Transaction**

If USAF FAC 3.0 is involved in a merger, acquisition or asset sale, your Personal Data may be transferred. We will provide notice before your Personal Data is transferred and becomes subject to a different Privacy Policy.
